Grounds entertainers include Living history Groups, dancers, demonstrators, animal groups, or any other nonmusical entertainer or demonstrator. Entertainers selected may be invited to perform on the festival grounds, Oak Grove stage, Pine Tree stage, Welcome stage, or Sugar Pine stage.

- Deadline for submissions is July 20. Gate list by August 10 Confirmations will be sent as groups are selected.
- All applicants must complete this application and submit it along with;
- Name and ages(if under 18) of all performers and what they do
- High resolution black and white or color photo.
- Video of live performance is preferred but not required.
- Entertainer bio.
- Stage plot indicating placement and space desired. If space not available, this could be a denial factor.

# Rules and Regulations

1. It is the responsibility of the artist or person in Charge to transfer all information regarding entertainer participation to group members.
2. KVMR employs a zero tolerance drug policy. Anyone using drugs will be required to leave and will not be invited to return.
3. Smoking is not permitted within the fairgrounds and is enforced by Fairgrounds personnel.
4. Camping is available and encourage for performers. A minimal amount per encampment (2 members) will be allowed in the encampment after faire hours. Please check with Fairgrounds personnel.
5. No Pets are allowed on festival grounds without prior written approval from Festival management.
6. Participants consent to use their names, pictures, images, recorded voices or music in connection with festival events and without inspection for such purposes and commercial or promotional use.
7. All Faire participants given passes into faire must be in costume.
8. All Faire participants given passes into faire must be in costume during Saturday parade..
9. There will be check in for participants on Friday night and Saturday until 12:01 PM. There will be no check in on Sunday.
10. Camp fires: All fires are not allowed according to the fire marshal and fire conditions. Check with Festival management for any changes.
11. All artist/group members agree to comply with festival, Federal, State, County, and local ordinances.
12. For Living history groups, members agree to not dismantle encampment prior to 8 PM on Sunday night without prior approval. Dismantling your encampment creates distraction from the main stage performers before the close of the festival. Check with Fairgrounds personnel. Soft tear down and quiet carry out is allowed. No vehicles will be allowed on site until 10:00 PM Sunday.
13. All members agree to defend, indemnify, and hold harmless John Taber (Executive Producer), Nevada City Community Broadcast Group, Inc., the Nevada County Fairgrounds or any other festival site or management , their officers, boards, employees, volunteers, independent contractors, or agents for any liability and damages whatsoever, including, but not limited to, property damage, personal injury, or death arising out of or in any manner connected with the use of premises, without festivals permission.
14. Groups are limited to a maximum of 100 participants.

# State Fire Marshall Compliance Procedure for KVMR Celtic Festival

1. All Vendors & Guilds will have a structure that is a fire retardant treated or permanently tagged by the manufacturer and inherently fire resistant.

If the manufacturer does not tag your unit you may treat it yourself and you are required to do so. Please be prepared to show proof that you have done so. We suggest you maintain a folder with photos of the material being treated with date stamps on the photos. Additionally have dated sales receipts for the fire retardant you purchased. These will need to be presented to Festival Staff on arrival prior to set up. No one will be allowed to set up without proof that their unit is in compliance with State Fire Marshall mandates as outlined in the attached checklist.

2. All booths will have a currently tagged Fire Extinguisher secured in plain sight inside the booth. Fire extinguishers must be 2A 10 BC rated. Vendors using a deep fat fryer will have a Class K Extinguisher secured in the booth. Extinguishers will need to be inspected by Festival Staff on arrival prior to set up.

3. Extension cords will be heavy-duty 3 wire grounded cords not in excess of 20 feet in length.

Under no condition will any 2-wire cords be deployed in any booth or tent.
